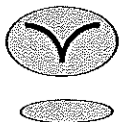
FIRST-AID MEASURES

Wear self-contained breathing apparatus and protective clothing to prevent contact with the skin and eyes.

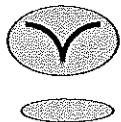
ACCIDENTAL RELEASE MEASURES

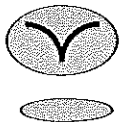
